ASSIGNMENT OF OVERRIDING ROYALTY INTEREST

THAT, this Amendment and Act of Correction to Assignment of Overriding Royalty Interest (the "Amendment") is executed by and between **HEDV String Music, LLC**, (sometimes hereinafter referred to as "HEDV" and/or as "Assignor"), a Texas limited liability company, having an address at Two Allen Center, 1200 Smith, Suite 2400, Houston, Texas 77002, and **HE&D Offshore, L.P.**, (sometimes hereinafter referred to as "HE&D" and/or "Assignee"), a Texas limited partnership, having an address at Two Allen Center, 1200 Smith, Suite 2400, Houston, Texas 77002. Assignor and Assignee may hereinafter be referred to individually as a "Party" and collectively as the "Parties."

**WITNESSETH:**

WHEREAS, pursuant to that certain Assignment of Overriding Royalty Interest dated effective September 1, 2017 (the "Assignment"), HEDV assigned to HE&D an overriding royalty interest equal to three percent of eight-eighths (3.00% of 8/8ths) in and to the oil, gas, casinghead gas, condensate, distillate, gaseous substances and all other hydrocarbons produced, saved, removed or sold from, or attributable to the following described Oil and Gas Lease (the "Lease"):

Oil and Gas Lease of Submerged Lands under the Outer Continental Shelf Lands Act, bearing serial number OCS-G 35821, dated effective July 1, 2016, between the United States of America, as Lessor, and Deep Gulf Energy III, LLC, as Lessee, covering all of Block 385, Mississippi Canyon, OCS Official Protraction Diagram NH16-10, covering 5,760 acres.

**WHEREAS**, the Assignment was filed on March 22, 2024 in the non-required files maintained by the Bureau of Ocean Energy Management for the Lease, and recorded on April 15, 2024, in Book 1475, Page 18, under File No. 2024-00001048, in the Conveyance records of Plaquemines Parish, Louisiana;

**WHEREAS**, the Assignment mistakenly listed the overriding royalty interest conveyed therein as being equal to 3% of 8/8, while the Parties intended that an overriding royalty interest equal to one percent of eight-eighths (1.00% of 8/8ths) be assigned to HE&D in and to the Lease;

**WHEREAS**, the Parties desire to amend and correct the Assignment to reflect the Parties intent that the overriding royalty interest assigned to HE&D is equal to 1.00% of 8/8ths.

**NOW, THEREFORE**, in consideration of the mutual understanding of the Parties hereto and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and in order that the public records accurately reflect the intention of the Parties with respect to the matters provided for herein, the Parties, intending to be legally bound by the terms hereof, agree as follows:

1. The Assignment is hereby corrected and amended to provide that the overriding royalty interest conveyed therein is equal to one percent of eight-eighths (1.00% of 8/8ths) in and to the oil, gas, casinghead gas, condensate, distillate, gaseous substances and all other hydrocarbons produced, saved, removed or sold from, or attributable to the Lease (the "Overriding Royalty"), subject to proportionate reduction as provided for in the Assignment.

All references to the Assignment shall be considered to be references to the Assignment as modified by this Amendment and, except as modified hereby, the Assignment (as amended hereby) shall remain in full force and effect. The Parties ratify and confirm the Assignment (as amended hereby) for all intents and purposes.

This Amendment shall be binding upon the Parties and upon their respective heirs, successors and assigns.

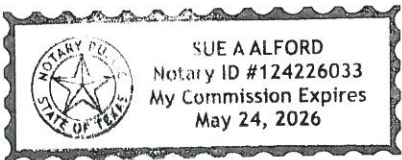

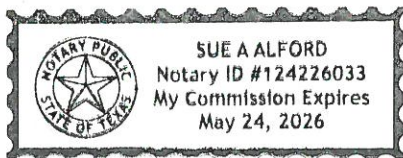
