STIPULATION OF OWNERSHIP INTERESTS AND ASSIGNMENT

(OCS-G 36657, Green Canyon Block 899, and OCS-G 36658, Green Canyon Block, 900)

UNITED STATES OF AMERICA

OUTER CONTINENTAL SHELF

OFFSHORE LOUISIANA

This Stipulation of Ownership Interests and Assignment (this “**Agreement**”) is executed by and among the following parties (collectively, the “**WI Owners**” and each individually a “**WI Owner**”), as of the date indicated in their respective acknowledgements, but effective as of August 2, 2024 (the “**Effective Date**”), to-wit:

Beacon Offshore Energy Exploration LLC (“Beacon”), a Delaware limited liability company, whose address is 333 Clay Street, Suite 4200, Houston, Texas 77002;

BOE Exploration & Production LLC (“BOEEP”), a Delaware limited liability company, whose address is 333 Clay Street, Suite 4200, Houston, Texas 77002;

Kosmos Energy Gulf of Mexico Operations, LLC (“Kosmos”), a Delaware limited liability company, whose address is 15011 Katy Freeway, Suite 700, Houston, Texas 77094;

Westlawn GOM Asset 3 Holdco LLC (“Westlawn”), a Delaware limited liability company, whose address is 4801 Woodway Drive, Suite 455E, Houston, Texas 77056;

CSL Exploration, LP (“CSL”), a Texas limited partnership, whose address is 1000 Louisiana Street, Suite 7000, Houston, Texas 77002;

Red Willow Offshore, LLC (“Red Willow”), a Colorado limited liability company, whose address is 1415 Louisiana Street, Suite 4000, Houston, Texas 77002; and

Alta Mar Energy (Winterfell), LLC (“Alta Mar”), a Texas limited liability company, whose address is 1201 Louisiana, Suite 730, Houston, Texas 77002.

The ORRI Owner (as such term is defined below) joins in the execution of this Agreement to evidence their acceptance of the terms and provisions of this Agreement. The ORRI Owner, together with the WI Owners, may hereafter be referred to collectively as the “**Parties**” or each individually as a “**Party**”.

1.

WHEREAS, reference is hereby made for all purposes to the following described federal offshore oil and gas leases, to-wit:

- (a) Oil and Gas Lease of Submerged Lands under the Outer Continental Shelf Lands Act, bearing Serial Number OCS-G 36657, dated effective as of June 1, 2019, between the United States of America, as Lessor, and Kosmos Energy Gulf of Mexico Operations, LLC, as Lessee, covering all of Block 899, Green Canyon, OCS Official Protraction Diagram, NG 15-03, containing approximately 5760 acres, more or less (the "**GC 899 Lease**"); and
- (b) Oil and Gas Lease of Submerged Lands under the Outer Continental Shelf Lands Act, bearing Serial Number OCS-G 36658, dated effective as of June 1, 2019, between the United States of America, as Lessor, and Kosmos Energy Gulf of Mexico Operations, LLC, as Lessee, covering all of Block 900, Green Canyon, OCS Official Protraction Diagram, NG 15-03, containing approximately 5760 acres, more or less (the "**GC 900 Lease**", together with the GC 899 Lease the "**Subject Leases**").

WHEREAS, each of the Subject Leases provides for a lessor's royalty equal to 18.75% (the "**Lessor's Royalty**").

2.

WHEREAS, as of the Effective Date, the WI Owners hold the following record title interests in and to each of the Subject Leases, to-wit:

WHEREAS, Kosmos has, through various instruments in the chain of title of the Subject Leases, retained various overriding royalty interests as further described on Exhibit 1 hereto (the "**Initial Permitted Encumbrances**") that burden certain of the record title interests held by the WI Owners in the Subject Leases.

WHEREAS, the Initial Permitted Encumbrances are borne by certain of the WI Owners in accordance with the chain-of-title documents filed with the Bureau of Ocean Energy Management (the “**BOEM**”) and in the public records of the parish adjacent to the Subject Leases.

4.

WHEREAS, Kosmos acquired a working interest in the Subject Leases from Red Willow by assignment dated effective March 29, 2022, at 7:00 a.m. local time where the Subject Leases are located, and such assignment was made subject to a portion of Initial Permitted Encumbrances burdening the working interest of Red Willow.

5.

WHEREAS, Kosmos acquired a working interest in the Subject Leases from Ridgewood Monarch North, LLC (“**RMN**”) by assignment dated effective April 1, 2022, at 7:00 a.m. local time where the Subject Leases are located, and such assignment was made subject to a portion of Initial Permitted Encumbrances burdening the working interest of RMN.

WHEREAS, Kosmos desires to clarify that the portions of the Initial Permitted Encumbrances to which Kosmos was made subject pursuant to the aforementioned assignments from Red Willow and RMN (such portions collectively, the “**Merging Interests**”) merged with and into the working interest of Kosmos in each of the Subject Leases effective as of the effective date of such assignments (with the remainder of the Initial Permitted Encumbrances remaining after the merger of interest in this section 6 being the “**Permitted Encumbrances**”, and with Kosmos, in capacity of the holder of these Permitted Encumbrances, the “**ORRI Owner**”).

7.

WHEREAS, the Parties, among other matters, desire to provide a firm statement of ownership of their respective working and net revenue interests in the Subject Leases, as well as confirmation of the quantum of the Permitted Encumbrances borne by each and to stipulate same as shown in the chart in section 8(B) below.

8.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged by the Parties, and in order that the public records accurately reflect the intention of the Parties as set forth herein, the Parties do hereby and by these presents stipulate and agree as follows:

A. The Merging Interests applicable to each Subject Lease are hereby merged with and into the respective existing working interest of Kosmos in such Subject Lease. The Permitted Encumbrances will not be deemed merged with the remaining Record Title Interest of Kosmos by virtue of this Agreement

B. The WI Owners and the ORRI Owner: 1) do hereby agree and stipulate that their respective working interests, the percentage interests of the Permitted Encumbrances borne by their respective working interests and their resultant net revenue interest in each of the Subject Leases and the ownership of the Permitted Encumbrances is as set forth in the chart below, and 2) do hereby by these presents transfer, convey, assign, set over and deliver to each other such interests in the Subject Leases as may be necessary to effectuate the ownership in the Subject Leases, net revenue interests and the ownership of the Permitted Encumbrances as set forth in the chart below:

This Agreement shall be binding upon the Parties and upon their respective successors and assigns. This Agreement may be executed in any number of counterparts; provided, however, neither this Agreement, nor any counterpart hereof, shall be binding or effective on any of the Parties, unless and until this Agreement, or a counterpart hereof, is executed by all of the Parties. For convenience of filing and recording in appropriate jurisdictions, the executed signature and acknowledgement page for each of the Parties can be compiled into one document for filing and recording.
