

**WHEREAS**, LLOG Exploration Offshore, L.L.C. (“**LEO**”), Deepwater Development Company LLC (“**DDC**”, formerly LLOG Deepwater Development Company, L.L.C.) and CNOOC Petroleum Offshore U.S.A. Inc. (“**CNOOC**”, formerly Nexen Petroleum Offshore U.S.A. Inc.) entered into that certain Acreage Exchange Agreement dated effective January 1, 2012, as amended (the “**AEA**”) whereby DDC acquired a one hundred percent (100%) of eight-eighths operating rights interest from CNOOC in and to the east half (E/2) of the Lease insofar and only insofar as to those depths from 13,000’ TVD down to 18,500’ TVD (“**Contractual Depths**”). Notwithstanding the Contractual Depths acquired by DDC in and to the east half (E/2) of the Lease, CNOOC and DDC filed Form-BOEM 0151 (Assignment of Operating Rights Interest in Federal OCS Oil and Gas Lease) with the BOEM covering those depths from 13,000’ TVDSS down to 18,500’ TVDSS (“**BOEM Ownership Depths**”).

**WHEREAS**, LEO, on behalf of LOH and DDC, their successors and assigns, entered into that certain Letter Agreement dated December 15, 2023 with Eni Petroleum US LLC (“**Eni**”) and CNOOC, whereby the parties thereto agreed to correct the BOEM Ownership Depths so that the BOEM’s records reflect the Contractual Depths acquired by DDC and LOH in and to the east half (E/2) of the Lease pursuant to the AEA.

**WHEREAS**, LDDC II, Westlawn and KUSA, as the other current working interest owners of the BOEM Ownership Depths, also agreed to the correction of such depths pursuant to that certain Letter Agreement dated December 27, 2023, effective December 29, 2023 as set forth herein;

**WHEREAS**, the Working Interest Owners, CNOOC and Eni entered into and filed with BOEM various Form-BOEM 0151 (Assignment of Operating Rights Interest in Federal OCS Oil and Gas Lease) and BOEM 0150 (Assignment of Record Title Interest in Federal OCS Oil and Gas Lease) assignments and reassignments to correct the BOEM Ownership Depths, such that the BOEM's records reflect the Contractual Depths acquired by DDC and LOH, their successors and assigns, in and to the east half (E/2) of the Lease pursuant to the AEA (collectively, the "**Corrective Assignments**");

**WHEREAS**, as a result of the Corrective Assignments, the operating rights depth interval owned by LOH and DDC, their successors and assigns, in and to the east half (E/2) of the Lease are those depths and zones between 12,915' TVDSS down to 18,415' TVDSS (which depths are equivalent to 13,000' TVD down to 18,500' TVD) (the "**Corrected Depths**").

**WHEREAS**, the Parties now desire to amend the ORRI granted pursuant to the ORRI Assignments, to the extent and only to the extent necessary, to amend the depths of the lease description affected by the ORRI to make such depths consistent with the Corrected Depths, all subject to and in accordance with the terms and provisions set forth below.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged by each of the Parties, and in order that the public records accurately reflect the intention of the Parties with respect to the matters provided for herein, the Parties agree as follows:

The description of the Lease burdened by the ORRI pursuant to the ORRI Assignments, as amended hereby, shall be as follows:

Oil and Gas Lease of Submerged Lands under the Outer Continental Shelf Lands Act, bearing Serial No. OCS-G 25098, dated effective July 1, 2003, granted by the United States of America, as Lessor, in favor of Nexen Petroleum Offshore U.S.A. Inc., as Lessee, covering all of Block 546, Mississippi Canyon, as shown on OCS Official Protraction Diagram, NH16-10, **INSOFAR AND ONLY INSOFAR AS** said lease covers only the east half (E/2) of the Block and only as to those depths from 12,915' TVDSS down to 18,415' TVDSS.

This Instrument shall be binding upon each of the Parties hereto and upon their respective heirs, successors, and assigns.

Except as otherwise amended herein, the ORRI Assignments shall remain in full force and effect.


