Your letter dated May 21, 2024, requesting termination of the period of liability of Outer Continental Shelf (OCS) Pipeline Right-of-Way Grant Bond No. SBP150014_045, in the amount of \$300,000, was received by our office on May 22, 2024. This bond, conditioned to cover the principal's pipeline operations in the Gulf of Mexico, was executed on May 15, 2024, with Fieldwood SD Offshore LLC as principal and Pennsylvania Insurance Company as surety.

We are unable to grant your request for termination of this bond. The Office of Natural Resources Revenue has concerns, stating "Outstanding lease obligations (right-of-ways, minimum royalty, inspection fees) were found. Outstanding Interest invoices were found".
