Your letter dated April 25, 2024, requesting cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. SUR0016763, in the amount of \$369,000, was received by our office on that same date. This bond, conditioned to cover Right-of-Way OCS-G 0891, was executed on September 18, 2013, with Kinetica Partners, LLC as principal and Argonaut Insurance Company as surety.

We are unable to grant your request at this time because the Risk Management Operations Section (RMOS) has objected to this cancellation, and there is still decommissioning liability assessed for G 0891. When these have been corrected you may resubmit your request.
