Dear Mr. Young:

Your letter dated April 30, 2024, requesting cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. ROG0001504, in the amount of \$3,490,639, was received by our office on that same date. This bond, conditioned to cover Right-of-Way OCS-G 28611, was executed on February 14, 2019, with Deep Gulf Energy III, LLC as principal and RLI Insurance Company as surety.

Attached to and forming a part of Bond No. ROG0001504, is Name Change Bond Rider, executed on February 14, 2019, which changes the name of the principal from Deep Gulf Energy III, LLC to Kosmos Energy Gulf of Mexico Operations, LLC. The rider is effective February 14, 2019.

We are unable to grant your request at this time for the following reasons.

- Right-of-Way G28611 still has decommissioning liability assessed with no supplemental bonding other than Bond No. ROG0001504. General Bond No. RLB0015958 is a base bond and does not cover this type of liability.
- The Risk Management Operations Section has objected to this cancellation as there is still liability on this Right-of-Way.
- The bond number in the body of your letter of request is incorrect.

When these issues are corrected you may resubmit your request.
