Dear Mr. Knott:

Your letter dated April 24, 2024, requesting cancellation of Outer Continental Shelf (OCS) Pipeline Right-of-Way Grant Bond No. 6543125, in the amount of \$300,000, was received by our office on that same date. This bond, conditioned to cover the principal's pipeline operations in the Gulf of Mexico, was executed on February 20, 2008, with St. Mary Land & Exploration Company as principal and Safeco Insurance Company of America as surety.

Attached to and forming a part of Bond No. 6543125, is Name Change Bond Rider, executed on March 23, 2011, which changes the name of the principal from St. Mary Land & Exploration Company to SM Energy Company. The rider is effective June 1, 2010.

Pursuant to 30 CFR 556.906 (d)(1) your bond may be cancelled seven years after the termination of the lease, six years after completion of all bonded obligations, or at the conclusion of any appeals or litigation related to your bonded obligation, whichever is the latest. The period of liability of Bond 6543125 was terminated February 24, 2017.

The Bureau of Ocean Energy Management has no objection to cancellation of the above bond. Therefore, Bond No. 6543125 is considered cancelled without residual liability, effective May 7, 2024, the date of final concurrence with such cancellation.

SM Energy Company, Company Number 02308, hereby requests cancellation of Bond No. 6543125. This request is based on the fact that the period of liability under the bond terminated on February 24, 2017, and it has been seven years from the date of termination of this bond.
