Dear Mr. Colan:

Your letter dated November 4, 2024, requesting cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Bond No. RLB0015872, in the amount of \$50,000, was received by our office on that same date. This bond, conditioned to cover Lease OCS-G 34421, all of Block 75, Mississippi Canyon, was executed on December 2, 2014, with Deep Gulf Energy III, LLC as principal and RLI Insurance Company as surety.

Pursuant to 30 CFR 556.906 (d)(1) your bond may be cancelled seven years after the termination of the lease, six years after completion of all bonded obligations, or at the conclusion of any appeals or litigation related to your bonded obligation, whichever is the latest. These criteria have been met. The period of liability of Bond RLB0015872 was terminated October 13, 2017.

The Bureau of Ocean Energy Management has no objection to cancellation of the above bond. Therefore, Bond No. RLB0015872 is considered cancelled without residual liability, effective November 18, 2024, the date of final concurrence with such cancellation.
