Dear Ms. Koletar:

Your letter dated December 10, 2024, requesting cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. N-4000229, in the amount of \$7,432,543, was received by our office on that same date. This bond, conditioned to cover Lease OCS-G 13060, all of Block 784, Viosca Knoll, was executed on September 15, 2020, with W & T Energy VI, LLV as principal and Indemnity National Insurance Company as surety.

Attached to and forming a part of Bond No. N-4000229, is a Bond Rider, executed on September 8, 2023, which decreases the bond amount by \$3,913,842 for a total penal sum of \$3,518,701. The rider is effective September 8, 2023.

The Bureau of Ocean Energy Management has no objection to cancellation of Bond No. N-4000229, which is considered cancelled without residual liability effective December 11, 2024, the date of final concurrence with the cancellation.

Power of Attorney

KNOW ALL PERSONS BY THESE PRESENTS: that Indemnity National Insurance Company, a Mississippi corporation, (hereinafter the "Company"), does hereby constitute and appoint: ****Joseph R. Zuniga; Stephanie Moore Harold**** of ****McGriff Insurance Services, LLC**** to be its true and lawful Attorney-in-Fact, with full power and authority hereby conferred to sign, seal, and execute on its behalf surety bonds or undertakings and other documents of a similar nature issued in the course of its business up to a penal sum not to exceed *****Thirty million dollars (\$30,000,000.00)***** each, and to bind the Company thereby as fully and to the same extent as if the same were signed by the duly authorized officers of the Company.

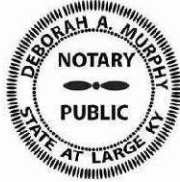
