Dear Mr. McGregor:

Your letter dated February 27, 2025, requesting termination of the period of liability and cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Bond No. 612403085, in the amount of \$500,000, was received by our office on February 28, 2025. This bond, conditioned to cover Lease OCS-G 11075, all of Block 562, Green Canyon, was executed on September 30, 2021, with OGOG (GOM 1) Inc. as principal and United States Fire Insurance Company as surety.

Attached to and forming a part of Bond No. 612403085, is Bond Rider No. 1, executed on July 26, 2022, which changes the name of the principal from OGOG (GOM 1) Inc. to OGOG (K2) Inc. The rider is effective July 14, 2022.

The Bureau of Ocean Energy Management has no objection to termination of Bond No. 612403085. The period of liability is considered to have terminated effective February 28, 2025, the date of final concurrence with the termination, except as to any liability which may have accrued prior to that date.

Notwithstanding the fact that the period of liability under the above-described bond has terminated, the bond cannot be cancelled until seven years after the termination of the lease, six years after completion of all bonded obligations, or at the conclusion of any appeals or litigation related to your bonded obligations, whichever is the latest. When these requirements have been met you may submit a written cancellation request.

Please note that during the aforementioned period, to cover actual or potential outstanding obligations associated with the herein identified lease, you may provide acceptable security, pledged collateral or another corporate surety bond to the Bureau of Ocean Energy Management in lieu of the above-described surety.

Please let this letter serve as OGOG (K2) Inc.'s (formerly OGOG (GOM 1) Inc.) (GOM No. 03614) request for cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Bond No. 612403085 covering Lease No. OCS-G 11075, All of Block 562, Green Canyon (the "Lease"), which was issued by United States Fire Insurance Company as Surety, dated September 30, 2021 and in the amount of \$500,000.00 (the "Bond"). A copy of the Bond is enclosed for your reference.

As reflected in BOEM/BSEE's records, there are several area-wide bonds currently supporting the Lease and the obligations associated therewith, namely the following:

- Outer Continental Shelf (OCS) Mineral Lessee's or Operators Bond No. **22015867**, in the amount of \$3,000,000.00, effective as of July 11, 2005, with **Anadarko Petroleum Corporation** as principal and Liberty Mutual Insurance Company as surety, conditioned to cover principal's leasehold interests held now or hereafter in the Gulf of Mexico.¹
- Outer Continental Shelf (OCS) Mineral Lessee's or Operators Bond No. 2971100-2657, in the amount of \$3,000,000.00, effective as of September 15, 1997, with Anadarko US Offshore LLC as principal and Safeco Insurance Company of America as surety, conditioned to cover principal's leasehold interests held now or hereafter in the Gulf of Mexico.²

Limited as principal and RLI Insurance Company of America as surety, conditioned to cover principal's leasehold interest held now or hereafter in the Gulf of Mexico.³

Pursuant to applicable regulations, OGOG (K2) Inc.'s bonding obligation was previously satisfied by issuance of the area-wide bonds identified above, such that issuance of the Bond was not required. See 30 C.F.R. § 556.900(c).

Accordingly, OGOG (K2) Inc. requests written cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Bond No. 612403085 terminating the period of liability of the Bond and cancelling the Bond without residual liability.

(a) to execute, affix the corporate seal manually or by facsimile to, acknowledge, verify and deliver any contracts, obligations, instruments and documents whatsoever in connection with its business including, without limiting the foregoing, any bonds, guarantees, undertakings, recognizances, powers of attorney or revocations of any powers of attorney, stipulations, policies of insurance, deeds, leases, mortgages, releases, satisfactions and agency agreements;

(b) to appoint, in writing, one or more persons for any or all of the purposes mentioned in the preceding paragraph (a), including affixing the seal of the Corporation.

Article III, Officers, Section 3.11, Facsimile Signatures. The signature of any officer authorized by the Corporation to sign any bonds, guarantees, undertakings, recognizances, stipulations, powers of attorney or revocations of any powers of attorney and policies of insurance issued by the Corporation may be printed, facsimile, lithographed or otherwise produced. In addition, if and as authorized by the Board of Directors, dividend warrants or checks, or other numerous instruments similar to one another in form, may be signed by the facsimile signature or signatures, lithographed or otherwise produced, of such officer or officers of the Corporation as from time to time may be authorized to sign such instruments on behalf of the Corporation.
