Your letter dated February 7, 2025, requesting cancellation of Outer Continental Shelf (OCS) Pipeline Right-of-Way Grant Bond No. SUR0058400, in the amount of \$300,000, was received by our office on February 20, 2025. This bond, conditioned to cover the principal's pipeline operations in the Gulf of Mexico, was executed on March 28, 2022, with Gulf Offshore LLC as principal and Argonaut Insurance Company as surety.
